1. Assumption of Risk and Responsibility

- A. Participant recognizes, understands, appreciates and acknowledges: (i) the risks and dangers of injury that may occur in the course of being on the premises of Palouse Empire Gymnastics Inc., located at 810 N. Almon Street, Building B, Moscow, Idaho, and/or PEG GymKids, located at 212 Rodeo Dr Suite 510, or any other future premises (the "Premises") and participating in the activities, including, but not limited to, activities involving motion, height and rotation, skills and techniques, and facilities, equipment, apparatus, mats, and pits unique to the sport of gymnastics and its various disciplines (the "Activities"); (ii) that my presence at the Premises and/or my participation in the Activities may involve risk of bodily injury (including, but not limited to, injuries to bones, joints, muscles and internal organs), illness, disability or paralysis (whether temporary, permanent, total or partial), death, or other harm; and (iii) that Participant voluntarily engages in the Activities with adequate prior knowledge of such risks and dangers.
- B. Participant voluntarily decides to enter said Premises knowing their condition, and participate in the Activities, and agrees to and does assume all legal and financial responsibility for: (i) any and all risks and dangers referred to in the preceding paragraph; (ii) any and all injuries, damages and losses, whether to person or property, and whether physical, psychological, social or economic, that Participant may in any manner and from whatever cause sustain in connection with attendance and participation in the Activities, including such injury, damage or loss that may result from the negligence of Palouse Empire Gymnastics Inc., PEG GymKids, its owners, directors, officers, employees, or agents (collectively "PEG") or from any other causes; and (iii) all treatment, hospitalization and other care rendered to Participant in the event of his/her injury, illness or other emergent circumstance in connection with any of the foregoing.

2. Liability Release and Indemnification. TUITION POLICIES (1 per family)

1. Registration Fees.

There is an annual registration fee of \$25/Participant due at the time of registration and again at the Participant's anniversary date. Participants enrolled only during the summer program pay a \$10 registration fee and the balance of \$15 is due if he/she register for classes in the fall/school year program. Registration fees are taxable, non-refundable and non-transferrable.

2. Tuition Policies for Classes.

* Fall semester: Families have the choice of paying the entire semester up-front for 10% off or dividing it into two ½ semester payments.

* Spring semester: Families have the choice of paying the entire semester up-front for 10% off, dividing it into two ½ semester payments or into 3 payments.

* Paying the full semester tuition up-front receives a 10% discount. Once the semester starts, the discount is no longer available.

*Pro-rating tuition will occur when a student starts mid-semester or is moving away from the area.

*\$10 late fee is applied if tuition is not received by the due dates listed in our parent info packet. Accounts 30 days overdue will be considered grounds for collections and the child will not be allowed to attend class. Statements will be sent via email and reminder signs will be posted in the building.

*There is a \$25.00 returned check charge for any checks returned by the bank. Cash or credit card payments will only be accepted from that point forward.

***Tuition is non-refundable.** In-house credit may be given for extenuating circumstances.

3. Missed lessons / Make-up Classes.

Tuition will not be prorated, credited, refunded or transferred for missed lessons. Make-up lessons are offered on Saturdays only, by reservation. Only currently enrolled students may take a make-up class.

For Example: Suzie missed class on October 17th; the 7-week block payment covers classes until October 21st. Suzie's parents have indicated that she will be stopping lessons. Her last opportunity as an enrolled student to take a make-up lesson is October 21st. Due to insurance regulations, she cannot take a lesson the following week, because she is no longer an enrolled and paying student.

4. Enrollment Status and Withdrawing from Classes.

*We do not have sessions. A student retains their spot in the class all school year long unless they drop-out. New students can join class anytime. Current students can transfer classes at any time.

*Two (2) weeks before the next payment is due, you will be emailed to see if your child will be continuing lessons. If not, we will note the drop date at the end of the payment period and open enrollment for others on the wait list.

Tuition will not be refunded for student dropping out before the end of the payment period.

For Example: Johnny's parents have paid for the entire semester of classes. Johnny no longer wants to take lessons. Tuition will be recalculated at the regular tuition rate for the lessons received and the balance will remain as a credit on the account to be used within 1 year's time.
